PROJECT OBJECTIVES:

- Analysis of the current situation in innovative business at the European level: trends, new business models based on information technologies and digitization;
- Determining the potential of the Republic of Moldova in the development of innovative business models and tools;
- Establishing the country's innovative business directions in terms of regional competition, determining the absorption capacity of innovative outputs;
- Determining the correlation between the demand and supply of human capital trained in the innovative business;


AS A RESULT OF PROJECT IMPLEMENTATION:


- We analyzed the possibility of using BIG Data and artificial intelligence in different business fields, mainly financial;
- We determined the impact of technology on the labor market, with reference to the structure, necessary skills;
- We quantified the impact of the use of advanced technologies on local business, on the field of training of specialists;
- We identified the factors that can boost or stop the assimilation of technologies and innovations as a whole;

ACHIEVED RESULTS ARE REFLECTED IN:

- 25 publications including: 14 articles in international journals, 2 chapters in international monographs, such as a collective monograph published abroad;
- 7 participation in International Conferences in Spain, Italy, Great Britain, Germany, Greece, USA, with publication of results in recognized databases;
- 2 Certificates of Registration of Copyright and Related Rights: years 2021, 2022, regarding the argumentation of the creation of public private partnerships in the financing of innovative business;

- We determined the absorption capacity of innovations in the Republic of Moldova;
- We analyzed innovation through a holistic, multidimensional approach, namely economic, psychological, social aspects.
- We deduced the point of singularity, for various fields, primarily for the financial sector, because it is the field that uses advanced technologies in customer service;
- We examined the regulatory framework in the PPP field, in order to boost the innovation activity and identified the factors that stop this process;
- We analyzed the possibility of amending the legislation of the Republic of Moldova regarding PPP, in order to minimize the risks for economic agents involved in innovative infrastructure projects;
- We proposed for the first time the use of PPP contract engineering according to the imperative requirements of the Legislation of the Republic of Moldova, a fact that will contribute to the efficiency of contract management. - We proposed and registered at AGEPI the Analysis Methodology of Public Private Partnerships (PPP) within investment projects, based on a system of indicators
